ACADEMIC PLANNING COMMITTEE SUMMARY OF ACTIVITIES

December 2004 - November 2005 Presented to the Academic Senate December 6, 2005

Membership

APC has been operating this semester without a full slate of members. Business was delayed at the October 5 meeting pending arrival of a quorum. There was no quorum at the October 19 meeting.

- Deborah Minter resigned as a Faculty Representative in August. Craig Eckhardt was appointed as an interim member until an election could be held. Eckhardt will not be available next semester. No new faculty member has been named.
- Sarah Morris, Undergraduate Student Representative, missed all six meetings from September to early November. She was the Undergraduate Student Representative in 2004-05 and missed six of ten meetings. APC asked ASUN to appoint a replacement for her. The position has not been filled.

Other Actions

- APC investigated the University's list of Centers to determine which ones had gone through the
 official approval process and whether some had been or should be discontinued. Procedures for
 reviewing centers were recommended.
- APC recommended procedures for degree name changes.
- APC endorsed the Development, Relief & Education for Alien Minors (DREAM) Act granting resident tuition rates to undocumented immigrants.
- APC recommended priorities for General Purpose Classroom renovations.

Upcoming Issues

APC's Long-Range Planning Subcommittee is developing a White Paper for Dr. Couture about cross-cutting themes that emerged from strategic planning. The subcommittee is suggesting processes to implement innovative ideas.
