Responsibilities:

- A. Formulate and recommend to the Faculty Senate, to the Colleges, and to the Chancellor goals for UNL in the areas of education (resident and extension), research, and service.

- D. The Committee is empowered to approve or disapprove proposed new academic programs and changes in existing programs, including elimination.
- E. Concern itself with goals, needs, and resources for a future period as long as is prudent and reasonable in view of the information and advice available.
- F. Changes or elimination of existing programs shall include time and opportunity for existing personnel to quality for a position in another program within the University whenever this requirement will not materially interfere with UNL achieving in full measure the goals of education, research, and service.
- G. Encourage academic planning within the colleges and other units of UNL on continuing basis through joint faculty-administrative-student action.

- Met with Chancellor Green to hear his decisions on the budget recommendations made by the APC. The Chancellor agreed with the APC to not eliminate the Department of Textiles, Merchandising, and Fashion Design and to retain the IANR tenured faculty member in Hospitality, Restaurant, Tourism and Management.
- The Long-Range Planning Subcommittee was charged with developing guidelines for reviewing program proposals.
- Chancellor Green gave his annual report to the APC at the April 21, 2021, meeting where he thanked the APC for its investment of time and energy in addressing the monumental budget reduction that the campus faced. He noted that the APC will start seeing an increase in the number of project initiation requests due to the approval of LB 588 which authorized funds for deferred maintenance of state buildings. He

- discussed retention and recruitment efforts and whether it would be possible to avoid some of the identified budget cuts if the University's financial situation improves. He discussed whether the University would have a vaccine mandate.
- Reports were given at most of the meetings from Executive Vice Chancellor Spiller (Academic Affairs), Vice Chancellor Boehm (IANR), and Vice Chancellor Wilhelm (Office of Research and Economic Development).
