### ACADEMIC PLANNING COMMITTEE (APC) ANNUAL REPORT TO THE UNL FACULTY SENATE Mehmet Can Vuran, Chair December 2022 – December 2023 Presented to the Faculty Senate on February 6, 2024

#### **Responsibilities:**

- A. Formulate and recommend to the Faculty Senate, to the Colleges, and to the Chancellor goals for UNL in the areas of education (resident and extension), research, and service.
- B. Recommend action to achieve the goals of UNL.
- C. Review with the Chancellor or appropriate Vice Chancellors the relevant campus physical planning documents as they relate to academic program needs and education research and service goals, and the Committee shall make recommendations.
- D. The Committee is empowered to approve or disapprove proposed new academic programs and changes in existing programs, including elimination.
- E. Concern itself with goals, needs, and resources for a future period as long as is prudent and reasonable in view of the information and advice available.
- F. Changes or elimination of existing programs shall include time and opportunity for existing personnel to quality for a position in another program within the University whenever this requirement will not materially interfere with UNL achieving in full measure the goals of education, research, and service.
- G. Encourage academic planning within the colleges and other units of UNL on continuing basis through joint faculty-administrative-student action.

# Summary of Activities (complete details can be found on the APC Minutes website <a href="https://www.unl.edu/apc/minutes">https://www.unl.edu/apc/minutes</a>):

- The APC considered and approved revisions to the Guidelines for Academic Program Reviews.
- The APC worked on drafting guidelines for Reviewing Program Proposals to assist new APC members when new program proposals are received. There was also discussion about reviewing and possibly revising the proposal template. Ankerson stated that she would bring the suggestions to her office staff to begin discussions on redesigning the template to improve the proposal process.

- Chancellor Green met with the APC on March 8, 2023, to report that he was setting in motion the Procedures to be Invoked for Significant Budget Reallocations and Reductions to address UNL's structural deficit. He noted that this initial reduction would be \$10,770,191 to our permanent budget but he pointed out that we will probably need to make further reductions in the fall.
- Chancellor Green met with the APC on April 19, to present a memo outlining the proposed budget reductions. In following meetings, the APC worked on reviewing the proposed reductions, raising questions, and seeking further information detailing the proposed reductions. The APC finalized its recommendations on the proposed revisions at its May 1, meeting.
- On August 23, meeting the APC began discussions about strategizing for the next round of budget cuts to address UNL's remaining structural deficit. The APC then met with Chancellor Bennett on September 6 to learn more about UNL's deficit and to discuss the work facing the APC this semester.
- The APC met with VC Zeleny on September 20, who presented an overview of UNL's budget showing the sources of funds coming into the campus but also showing the expenditures and the increases in expenditures which have contributed to the structural deficit.
- On October 4 Chancellor Bennett met with the APC to officially implement the Procedures to be Invoked for Significant Budget Reallocations and Reductions. Chancellor Bennett also informed the APC of the NU system deficit of \$58 million, the System's plans to initiate a hiring freeze for non-academic personnel, issuing a budget rescission, and had developed a 5-point plan which involves a zero-based budget to address the System's budget deficit. Chancellor Bennett met again with the APC on October 18 to discuss a revised budget framework which addresses only UNL's structural deficit of \$12 million and does not address any additional reductions that may come after the first of the year due to the NU system's deficit.
- The APC met weekly from October 18 through December 6 to review the proposed budget reductions and to make its recommendations. On November 15, the APC met with VC Barker to discuss the proposed reductions for the Office of Diversity and Inclusion.
- Reports were given at most of the meetings from Executive Vice Chancellor Ankerson (Academic Affairs), Vice Chancellor Boehm (IANR), and Vice Chancellor Wilhelm (Office of Research and Economic Development) and Interim Vice Chancellor Jones (Office of Research and Economic Development).
